## **Excelligent Expands Workforce**

Excelligent has grown their employee presence at Sandia National Laboratories and at the National Nuclear Security Administration's (NNSA) John A. Gordon Albuquerque Complex. The company also opened an office in Livermore, California, supporting Lawrence Livermore National Laboratory. Excelligent has a total of 18 employees in Albuquerque and California, 12 of them working in the SS&TP office. The company is part of the Enterprise-Wide Technical & Engineering Support Alliance III (E-TESA III) contract that was awarded in 2022 to support the NNSA.



### **Great Plains Partners Opens Office**

Great Plains Partners Venture Group, a private equity firm investing capital to mature and transition innovations to clients in the manufacturing, aerospace, and defense industries, opened a local office in the TEAM Technologies building, located in the SS&TP. The firm's leadership has substantial experience in technology maturation. In a collaborative TRGR Technology Readiness Initiative Project, Great Plains Partners is working on advancing a licensed Sandia technology that provides an alternative, environmentally benign domestic source of rare earth elements through its spin-off company, Critical Materials, LLC.







#### **MicroNet Sells Pix2Net to MITRE**

The MITRE Corporation has purchased Pix2Net Software Suite from MicroNet Solutions (MSI) and intends to scale and support the Pix2Net capability. While MITRE's primary mission is in support of the US government, MITRE plans to continue to make Pix2Net available for license. MSI remains the responsible licensor for current contracts. New license and contract agreements will be executed by MITRE, not MSI, but other than that change, the transition should be seamless. Former MSI President Mike Strizich and some MSI employees have joined MITRE.



## **Partners Release Call for Artists RFO**

The City of Albuquerque Arts Board and SS&TP Art Selection Committee have released a <u>Call for Artists RFQ</u> for a national open competition public art project. The large-scale, site-specific outdoor work of art will be installed in the SS&TP. The Art Selection Committee seeks to partner artists with SS&TP company representatives, scientists, and innovators to develop technology-based public art design proposals. The \$350,000 project budget is funded by the City's 1% for Public Art Program. The City is a key partner in the SS&TP.
